Additional Drivers - Must be **21 years of age** and have a valid driver's license in their possession while operating golf cart.

1. The following requirements must be met at time of registration :

- Proof of liability insurance with a minimum coverage of \$50,000. Provide copy of insurance certificate to the office.
- Sign this "Golf Cart Agreement"
- Pay Permit Fee of \$_____
- Inspection of the golf cart by Resort Management. Management reserves the right to refuse to register/permit carts that are deemed unsafe.

2. Permit must be clearly displayed cart at all times.

3. All operators of a golf cart must have in his/her possession a valid driver's license and must be at least 21 years of age. It is the Cart Owner/Camper's responsibility to ensure that anyone under the age of 21, or without a valid driver's license, does not operate your golf cart.

4. Passengers are limited to the number of seats on the golf cart.

5. Golf carts need to have operating fixed headlight(s) and reflectors in order to be driven at night.

6. Golf carts cannot be driven after quiet hours.

7. Golf carts are to be operated in a safe and reasonable manner at all times. Please stay on common roads at all times and abide by all posted speed limits. Do not drive the golf cart through campsites.

8. Children are not allowed to sit on the driver's lap or steer the cart.

9. Alcoholic beverages are prohibited on golf cart, and driving a golf cart while under the influence of alcohol or drugs which may cause impaired judgment will result in immediate expulsion from the Campgrounds **WITHOUT REFUND**.

10. All golf carts must be maintained in good working order.

11. Charging of golf carts is limited to your site only.

12. Failure to abide by any of the foregoing rules will result in immediate termination of your stay and removal of your golf cart from Hidden Creek Camping Resort property.

13. The Cart Owner/Camper agrees to hold Hidden Creek RV, LLC, its affiliates and Hidden Creek Camping Resort staff harmless, including attorneys' fees and costs from damage or liability, from any and all claims for injuries to persons or property, resulting from the operation of any golf cart owned or operated by the Cart Owner/Camper. Resort Management reserves the right to cancel your right to operate a golf cart in the event that any of the Golf Cart Rules herein are violated.
